Hi Ethan,

I noticed in your recent email that the German Nagios conference site is hosted at the following domains:

http://www.nagiosconference.com http://www.nagiosconference.org http://www.nagiosconference.de

This is problematic in regards to the Nagios trademark. In order to maintain the validity of the Nagios trademark, I need to make sure that it is not used in any manner that may be potentially confusing to users.

I would suggest the following changes to avert any potential problems:

- 1. Make sure the conference is called something like "German Conference for Nagios Users", "German Conference on Nagios" in any promotional material instead of "Nagios Conference" or "Nagios Conference for German Users". This ensures that users don't get the impression that it is "the official" Nagios conference, as that would be problematic with regards to the Nagios trademark. The difference in the title of the conference appears subtle, but is important in regards to trademark law.
- 2. Host the conference information on the Netways website under a URL like the following:

http://www.netways.de/nagiosconference

Doing this makes it apparent to users that the conference is associated with Netways, rather than being an "official" Nagios conference that I am sponsoring or organizing.

3. Stop using the nagiosconference. $\{ \operatorname{org} | \operatorname{com} | \operatorname{de} \}$ domains to promote the conference, as this would be problematic with regards to the Nagios trademark. These domains names make it appear as though the conference is an "official" one that is promoted or sponsored by me.

Since you've already used the domains mentioned in marketing material, I would be okay with having those domains automatically redirecting to a URL at the Netways website (as mentioned above) for a few months. After that period, the domain names should be abandoned to prevent future problems. As an alternative I could host the nagiosconference.* domains and promote the German conference for Nagios users on it. I would be happy to do this, and this would avoid trademark issues as they relate to the domains.

I apologize if these issues cause you any grief. I most certainly am looking forward to the conference and appreciate all that you and the folks at Netways are doing, but I need to make sure the Nagios trademark remains strong and protected.

FYI, I'll be traveling starting tomorrow afternoon and won't be back until Friday evening. I will most likely be unable

to access email while traveling, but I will respond to any emails as soon as I get back.

Until later, take care and best of luck.

Let me first say, that I understand most of your concerns and I am hopping to find a solution here, that we both can live with and have a good time at the conference together.

- 1) It is definitly no problem to make it more clear and visible on the website and other materials, that it is no official conference and you are only involved as a speaker. I think we would just call it "NETWAYS Conference for Nagios Professionals" or something else and put some statements on the website.
- 2) I have some experience in German trademark law as well, because we had our company name, our logo and some smaller stuff registered as trademarks and there were some other companies, using the same name. The first thing I learned is, that trademarks are national only. An US trademark is completly useless in Germany or other EU contries. There is a company called netways in Austria and I had no chance of prohibiting them to use the name, even with us having the registered trademark in Germany and being the older company. (They changed there name voluntary later, because we own netways.at :-))

The problem is theoretically even bigger, because someone could register nagios as a tredemark here and ban us (netways and other German companies) from using it. I don't know about US trademark law, but here a trademark is for preventing other to use the name. If something is already put into circulation, this prevents from registering it as a trademark. Maybe it wouldn't be a bad thing here, if everybody uses the name. Or you must register nagios as a trademark in all EU contries.

3) I don't understand why nagiosconference. {org|com|de|net} is a problem, while others like nagios-wiki.de or nagiosexchange.org are not?

Ok, please don't get me wrong, I definitly do not want to offend you, I just try to understand it a little better and find a compromise. I definitly understand, that you need to protect your trademark and if you insist on giving up the current domains I will do it.

Maybe you could just give us a license as it is sometimes done with the linux trademark.

What do you think about my points?
